#### DIRECTIONS FOR USE:

*Greens, Tees, Fairways, Lawns and Sports Turf*

**General Turf:** Covers 20,000 ft<sup>2</sup> at 2.5 lbs./1,000 ft<sup>2</sup>. Apply two applications 7 to 10 days apart to achieve management of water repellent conditions for 90 days.

**Water Repellent Management Program:** Apply two applications 7 to 10 days apart to achieve management of water repellent conditions for 90 days. Irrigation is necessary to release Brilliance Granular off its carrier. Irrigate before next mowing or leave baskets off. Irrigation after application is required to remove the surfactant from the leaf surfaces.

**Seeding:** Apply Brilliance Granular at a rate of 2.5 lbs./1,000 ft<sup>2</sup> two weeks prior to seeding. Irrigation is required after application to remove the carrier and surfactant from the leaf surfaces.

**Sodding:** After laying sod, broadcast Brilliance Granular at 2.5 lbs./1,000 ft<sup>2</sup>. Irrigation is required after application to remove the carrier and surfactant from the leaf surfaces. Apply two applications 7 to 10 days apart to achieve management of water repellent conditions for 90 days.
