Harrell's Green Spray Indicator is a proprietary colorant blend used as a visual aid to help identify areas covered by the applicator. For use with pesticides, fertilizers, and PGR foliar applications on turfgrass and other non-crop vegetation sites with all types of spray equipment.

Harrell's Green Spray Indicator leaves a temporary visual identification of the areas already treated by the applicator. Avoid the added cost of overlapping spray applications, and ensure that no areas are being skipped, saving you the time and expense of incomplete applications and re-treatments.

DIRECTIONS FOR USE:

For use on turfgrass and other non-crop vegetation sites.

RECOMMENDED RATES

Equipment	Application	Rate
Spray Tank	Dormant turf, greens, fairways	24 - 40 oz./acre
Backpack		1 -2 oz./gallon

Add Harrell's Green Spray Indicator to the spray tank after all other chemicals. Agitate as appropriate.

STORAGE AND CONTAINER DISPOSAL
